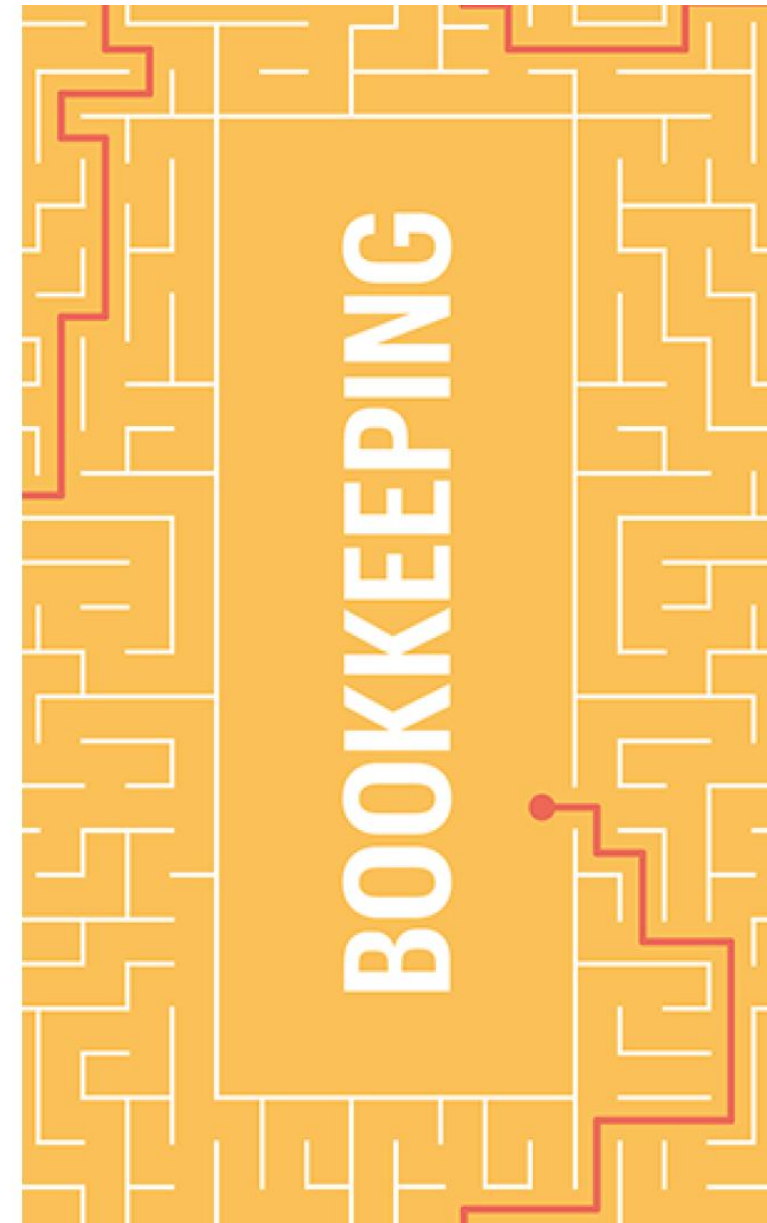

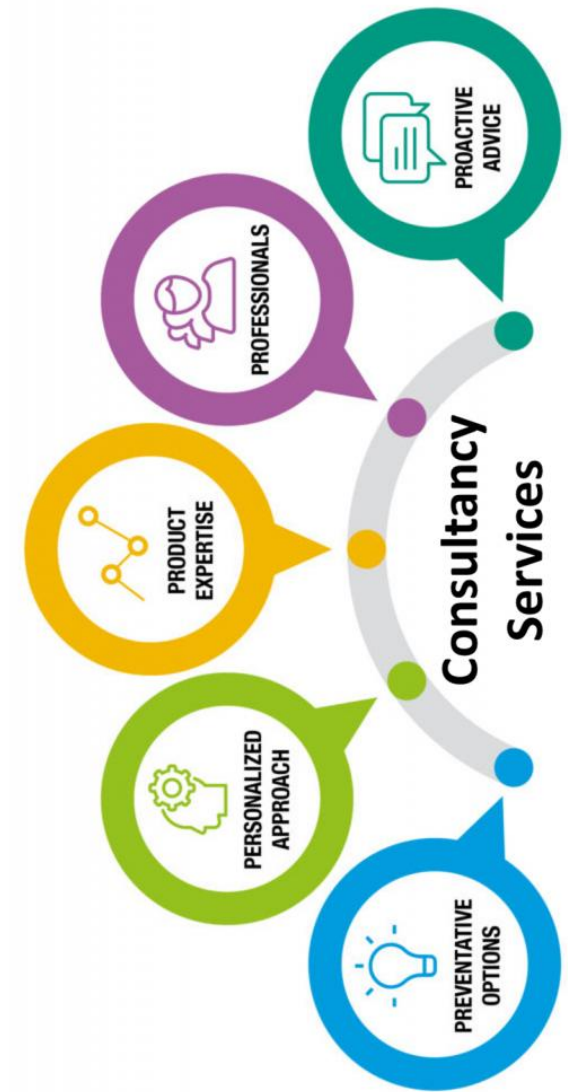

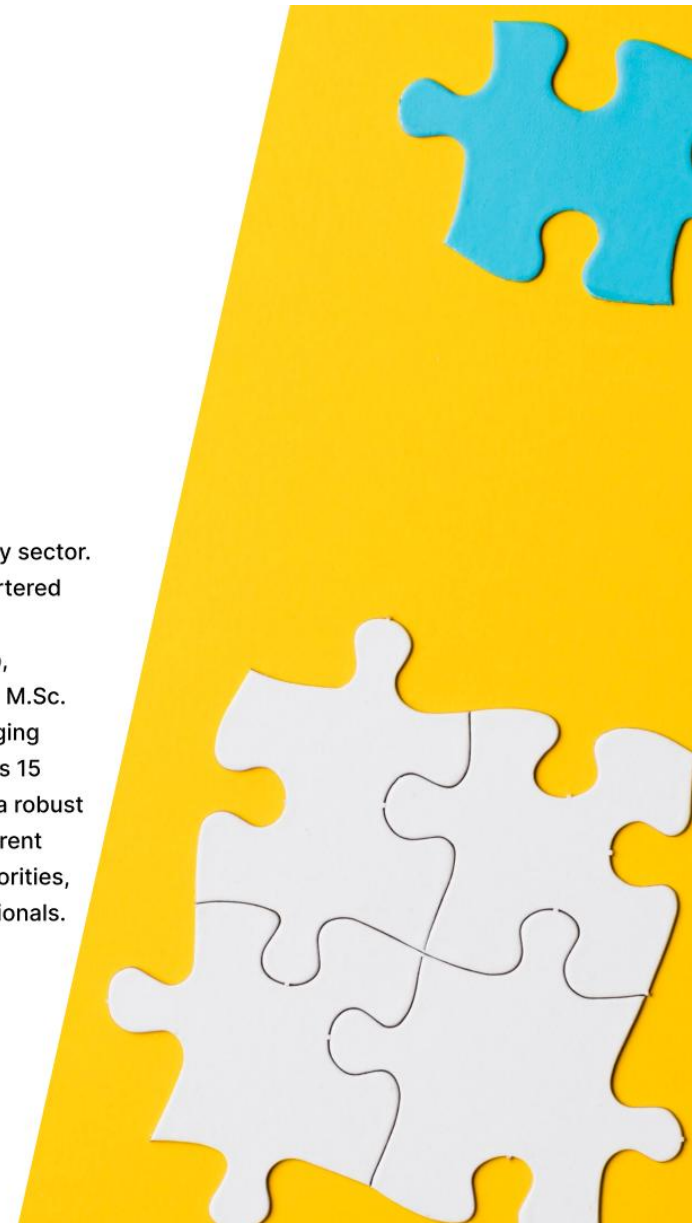
Muhammad Sochan – FCA

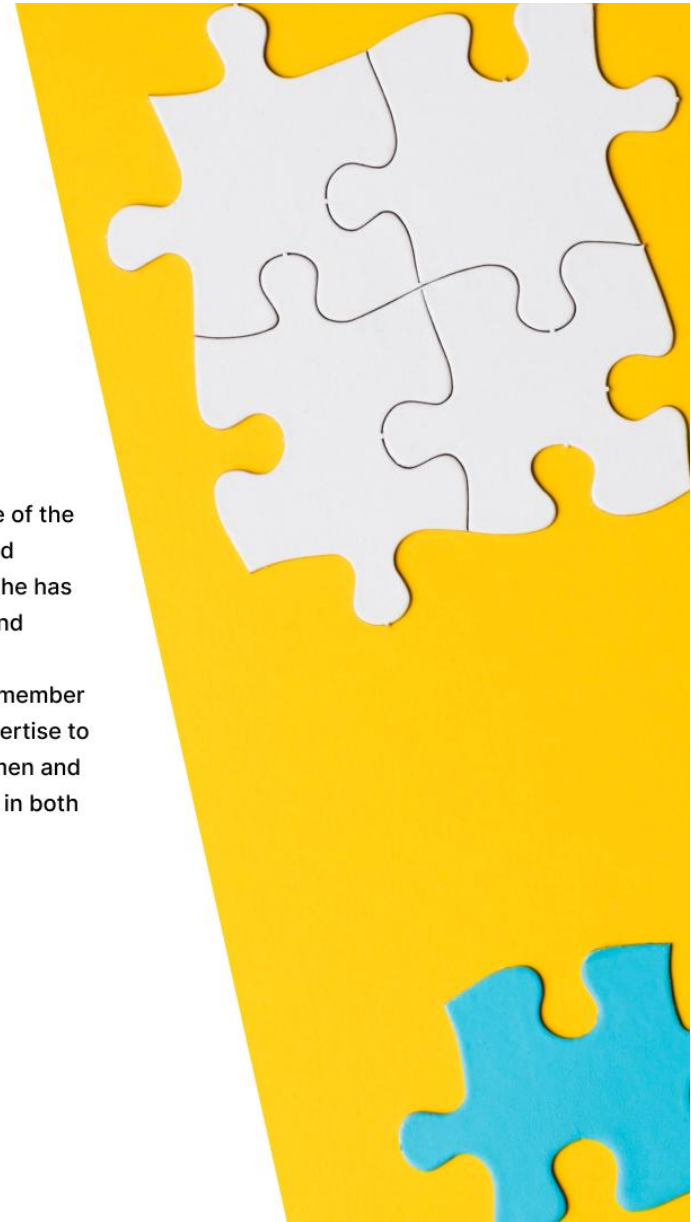
